ANNUAL MEETING:

SCHEDULED EVENTS:

June 25— Terry and Sharon are looking for volunteers to take kids out on their boats or help at the beach with teaching. Watch for the sign-up sheets to get your kids registered to participate. Lunch to be served after the fishing in the Pavilion. Contact Terry and Sharon Stone at Lot #36 for any additional questions.

July 2 – Potluck at the Pavilion. Dinner will be served from 5:00 to 7:00. The Association will be furnishing the meat. We ask that you bring one or more side dishes to share. We are still looking for volunteers to serve and clean up. Be courteous and toss your trash before you leave so there are clean seats for the next person to enjoy their dinner. After dinner, we are going to have a traveling after dinner drinks and or dessert. We are hoping that you will all get out and meet your neighbors and friends in the evening.

There will be no sponsored fireworks display this year. Personal fireworks need to follow the State Law (I confirmed with Sarpy County that anyone outside of city limits is governed by N.R.S §§28-1241, 28-1252, 84-201) A list of permissible fireworks is published each year by the State Fire Marshall. There is no set time in the Nebraska Statute that stipulates when fireworks can be discharged. However, everyone should be mindful of following the Campground rules for Quiet Time. State law prohibits the discharge of fireworks within 100' of any tent or canvas shelter and the potential landing area shall be a large, clear and open area. Fireworks may only be sold between June 24 and July 4.

July 3 – Golf Cart Parade. Meet at the Pavilion at 10 a.m. to line up. The parade has grown each year. There will be prizes awarded. Meet back at the Pavilion for the awarding of the prizes.

Late July (date to be determined) – BBQ Competition. Watch for details and date.

July/August (date to be determined) – 2^{nd} Annual Wine Tasting. This one is still in the organization stage but I have heard from Linda and Shelly that it is still a planned event.

August 13 – The annual Beerfest has been scheduled for the Horseshoe Bar. Watch for further details as the date gets closer.

Fishing – Follow the posted signs regarding catch and release. Remember, walleye are to be released. No exception. We are trying to stock the lake with Walleye. If you do not know what kind of fish it is, please study the pictures.

Nebraska State law applies to Linoma. It is unlawful to release any non-native fish in waters of the state or to release any fish in any public waters in the state except in those waters from which it originally came without written authorization from the Nebraska Game and Parks Commission.

Lot Improvements - all lot improvements must be approved by the owners. Before adding any structure, make sure you are going to be allowed to leave it.
